a. Charity donation to Ernie's Angels and Child Bereavement

## The JCR notes that:

- Ernie's Angels is a charity that aims to provide financial assistance via a grant for local families to assist with the palliative and funeral expenses of children within the Bailiwick of Guernsey.
- Guernsey is a small island just off of the coast of France and as such only has a small hospital making any complex or specialist care only accessible in Southampton which is a plane journey away, which makes it both financially stressful and difficult for close family who can't be with their loved ones in the hospital. The charity aims to be able to finance and

offset costs for travel, overseas care and funeral expenses, as well as assist in being awarded for services to organ donation.

- I have seen first-hand how these charities are able to help as recently I experienced my girlfriend having to go through this and can attest to how amazing the support has been for her whole family, not only in supporting them directly but also for assisting her family and allowing for them to be awarded the Order of St John's award for.
- There is limited support, both emotionally and financially for families and especially working parents who have had to experience the passing of a child in Guernsey and in the wider UK.
- However, I feel it will be beneficial and fair to split this between both a Guernsey and UK charity. Child Bereavement UK helps families to rebuild their lives when a child grieves or when a child dies. They support children and young people (up to the age of 25) when someone important to them has died or is not expected to live, and parents and the wider family when a baby or child of any age dies or is dying. They provide training to professionals in health and social care, education, emergency services and the voluntary and corporate sectors, equipping them to provide the best possible care to bereaved families.

# The JCR believes that:

- As a JCR we should look to support people undergoing grief even if they are not able to be assisted by University welfare services
- Assisting with grief extends beyond just grief counselling and includes other ways to be supported, both financially and emotionally

## The JCR resolves to:

• Donate £100 each to Ernie's Angels (Guernsey) and Child Bereavement (UK)

# The JCR believes that:

- Making quality amateur films is expensive. Funding provided by this JCR would allow the production team to pay for the locations, the rental of props, the use of high-quality technical equipment and the marketing of the project.
- It will be possible to view the film after it is made, which means that this funding will not only enrich those involved in the project, but also those who wish to watch the film after its release.
- The Oxford Drama Society and Oxford Film Foundation mainly function on JCRs across Oxford giving financial backing to projects. Without this funding, it becomes difficult to pursue artistic ventures.
- Supporting student artistic pursuits is an important aspect and role within JCRs across Oxford.

# e. SEHA

**Brodie:** Two meetings ago we talked about the SEHA, which is the alumni community. WE voted to make the payment non-mandatory. Me and Antonin, the MCR president, went to a meeting a couple of days later and basically got completely grilled, a little bit bullied. It wasn't a fun thing. So, that wasn't successful. Then Adam thankfully took my place at a meeting two weeks ago with Antonin to discuss it.

**Roble:** The main thing is in total they get about £20k a year from the JCR and MCR. The £8 charges that are mandatory each term on battles add up to £24 per person, I won't bore you with the maths. It's a sizeable amount of money that we don't have a choice in. We're trying to look into different funding models, they were slightly more receptive. It's an ongoing conversation which Brodie is going to continue. They're slightly more open to looking into a different model by which we do it. Like an optional leavers gift, so when you leave you might pay £40 in one go. What you get in return is the water bottles that were here ages ago, the keep cups in freshers packs and stuff. They also organise the odd dinner for alumni in London which you'd have the option to be invited to and there might be one abroad. They do some good things and we learnt more about that. It's about being more aware of what they do and thinking about a more efficient way to get bang for our buck. I'm sure Brodie will do a good job next term continuing the conversation to make sure we're not paying for nothing.

**Brodie:** They are also still sitting on this lump of money that they're looking to spend. It's kind of a contradictory thing, they're taking our money, not letting us not give our money and have no idea what to spend it on. So, any suggestions, we'd have to split it with the MCR as well.

**Roble:** An idea which they liked is having a yearly BBQ in the graveyard that's free for everyone in the college. A big hall spirit thing that's regular year on year. They're really open to suggestions, they don't have a clue what to spend the money on.

Chair: I suppose any ideas you have, message them to Brodie.

Q: When you said you went to a meeting, who has the right to reject us leaving? Was it the college?

**Brodie:** Technically they don't have the right to reject us. Cathy is with us the whole way; the finance bursar Eleanor is too. We could technically say we're not paying you anymore. But they do organise fundraising things for college, which brings in a lot. Especially for new Norham. That's the last resort, we don't want to drop a nuke on them. We want to be more diplomatic about it. Pissing off our alumni community is putting us in bad straits for the next 10-15 years.
